This year the competition will again be a one day event and will be on Saturday, 13 April 2013.

The 2013 Competition & Show will be held at the Quinte Sports Centre, 265 Cannifton Road. Directions: From Hwy 401 take exit #544 and go south on Cannifton Road (Hwy 37). The Sports Centre is on the East side of Cannifton Rd just past the Petro-Can Gas Station.

The Purchase Award will consist of a Male Redwing Blackbird with \$500 cash for 1st place and Lee Valley gift Certificates of \$75 and \$25 for second and third places.

We suggest that prospective competitors review the carving classes and rules prior to entering the 2013 competition. QWCA is committed to maintaining our show as a pure carving show and to keep it as one of the better Canadian Carving Competition/Show events.

Plans for a successful show must be made well in advance and we now ask prospective show participants, who wish table space on 13 April 2013, to review the enclosed rules and costs (see reverse) and complete the attached application form and mail to Brian Hodgins prior to January 31, 2013. Space is limited and applications will be accepted on a first come, first served basis. All applications will be date stamped. Both successful and unsuccessful applicants will be notified during March 2013.

1. The Association wishes our show to be a pure woodcarving event. Other mediums will be discouraged and if in doubt, please submit a sample of you work to the executive of the QWCA for a ruling.
2. The Association will not be responsible for loss or damage to any article shown.
3. Any insurance will be the responsibility of the individual exhibitor.
4. All displays will be set up prior to **9:30 A.M. and remain until 4:30 P.M.**
5. The Association may limit the number of dealers selling carving supplies due to the limited space. Last years participants will be given preference and new applicants will be considered on a first come, first served basis.
6. Admission to the show this year will be a \$5.00 ticket on the door prize. Children under 12 years of age will be admitted free if accompanied by an adult. Advance admission will cost \$3.00.
7. This year, all tables will be six feet and the charge will be \$20 per table.
8. Table cloths will be available at a rental cost of \$4 each.
9. To allow space requirements to be solved/determined, you are urged to complete and forward your application as soon as possible. (The deadline is January 31, 2013).
